# **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to https://ewebzen.com/ and Prima Studio Designs, LLC, dba eWeb Zen and governs data collection and usage. # **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, Zen may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address

If you purchase Zen's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.
